The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 4 – Insurances

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s):

AKK-Motorsport ry (ASN) affects a Master Insurance Policy in respect of Third-Party Civil Liability with a value of EUR 505 564 for any one accident. The insurance company is IF P & C INSURANCE COMPANY LTD.

According to Finnish traffic law every car must have Motor Vehicle Insurance. The Organiser will acquire the insurances for foreign racing cars. Information about the cars must be sent to the secretary of the event latest on Friday 20th of May. Needed information: Name of the driver, Competition class, car manufacturer, car model and chassis number. Price for the insurance is EUR 50 / car. Competitors must pay the motor vehicle insurance in administrative checking on Friday 27th of May.

All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the Competition, together with the required protest fee.
