REGULATIONS

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

The Competition shall be run in accordance with the 2024 RallyX sporting regulations, 2024 Swedish Automobile Association's national competition rules, the FIA International Sporting Code and its appendices and these Supplementary regulations.
