III GENERAL INSTRUCIONS

1. General description of the track

The race will be held on an asphalt covered track intended for motor sports.

Address of the competition venue: Hikiäntie 1508, 05820 Hyvinkää

2. Competition classes

Class Drifting NEZ Pro

3. Registration

All drivers with national licenses from NEZ countries can participate and are responsible to have insurance in license or separate. Drivers from other countries can participate, they must have valid license issued by their country ASN.

Registration must be done no later than Sunday, April 17th pm 11:55.

Use of competitor data by the competition organizer:

When registering for the competition, the competitor accepts the processing of the personal data provided by the competition organizer, as well as the publication of specified (name, club, etc.) personal data in the list of participants, list of results, etc. in competition communication.

4. Registration fee

Registration fee is 150€

Payment at the administrative checking. Cash or card payment is accepted.

4.1 – Insurances

In compliance with the legal prescriptions, the Organizer has contracted one or several insurance(s) guaranteeing the following risk(s):

AKK-Motorsport ry (ASN) affects a Master Insurance Policy in respect of Third-Party Civil Liability with a value of EUR 1 million for any one accident.

According to Finnish traffic law every car must have Motor Vehicle Insurance. The Organizer will acquire the insurances for foreign racing cars. Information about cars will be collected in the registration form. If you have your own insurance for the racing car you don't need this insurance from the organizer but you need to send a certificate in english from your insurance company of this insurance to the organizer with email to the secretary [heli.lahtisaloranta\(at\)gmail.com](mailto:heli.lahtisaloranta@gmail.com).

Needed information: Name of the driver, Competition class, car manufacturer, car model and chassis number. The price for the insurance is EUR 50 / car and has to be paid at the administrative checking

NOTICE! This insurance does not cover driver's personal damage / bodily injuries. Please make sure that personal insurance for the drivers is adequate.

5. Paddock

It is possible to start setting up the pits in the paddock area on Thursday 24.4.2025 at 16:00. Starting the race car is strictly forbidden between 20:00 and 09:00. If this rule is not followed it is possible to be excluded from the competition.

When entering the paddock, you must obey the instructions of the paddock marshal. In addition to the race car, there can be only one service car per team in the paddock area. Trailers should be taken to the trailer parking area and other vehicles to the assigned parking area.

Due to the order of the rescue authorities, we have had to tighten supervision, including the width of rescue routes. For this reason, no part of the pit structures may exceed the edge of the pit. This applies to all structures (tents, awnings, carpets, tools, spare parts, etc.) and all vehicles. If negligence is detected, they must be corrected immediately. For repeated warnings, the organizer may impose a fine of 500 € / warning.

Each competitor and/or team must have a fire extinguisher weighing at least 6 kg and a fire blanket that is ready to use and approved by the authorities. The extinguisher must be marked with maintenance and inspection information and the dates must be valid. The extinguisher must be placed in a visible place at the pit area and easily accessible.

There must be a liquid-impermeable protective cover under both the racing car and the service car in the pit area. The protective cover must be at least as large as the race car and the service car. In addition, each competitor must have an absorbent mat intended to prevent oil damage, the absorption capacity of which corresponds to the total amount of oil in the race car.

The competitor is responsible for transporting the tires used during the competition from the competition area under threat of a fine. The driver is responsible for any damage caused to the track and its surroundings. The driver is responsible for all acts and omissions of his assistants.

The alcohol limit is absolutely 0.00‰. The use of alcohol in the pit area is absolutely prohibited. All competitors may be tested.

6. Advertising

A competitor who has registered for the competition reserves an area of approximately 20 cm from the top edge of the windscreen of their race car for the organizer's advertisement. The competitor can redeem the advertising space reserved at the top edge of the windscreen for a fee of 150 €. The payment is made upon registration.

7. Competition procedure

The NEZ Drift rd1 Hyvinkää competition is organized with the permission of AKK-Motorsport ry, in accordance with the National Regulations for Motorsport in Finland 2025, the Drifting Competition regulations and the Drifting NEZ Series regulations.

If the Series Regulations do not state the matter, the text of the Finnish Competition Regulations shall prevail.

In addition, the Drifting technical rules and regulations confirmed by the Finnish ASN shall prevail. If necessary, the Series and Competition Regulations may be amended or specified by additional regulations.

7.1 Technical scrutineering

Before participating in the first driving practice, cars must pass technical scrutineering, which will determine that they meet the technical regulations of their class. The decibel limit on the day of the competition is 110 dB / 4500 rpm.

The race car must have at least valid motor liability insurance. The rolling technical scrutineering will be at the competition venue on 24.4.2025 starting at 18:00 until 20:00 and continues 25.4.2025 at 7:30 to 9:45

7.2 Drivers briefing

Each driver who has registered for the competition at the competition venue must participate in the driver's briefings.
