REGULATIONS

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

The Competition shall be run in accordance with the 2025 RallyX sporting regulations, 2025 Swedish Automobile Association's national competition rules, 2025 Finnish Automobile association AKK-Motorsports ry (AKK) competition rules, the International Sporting Code and its appendices and these Supplementary regulations.

Article 4 – Insurances

AKK-Motorsport ry (ASN) affects a Master Insurance Policy in respect of Third-Party Civil Liability with a value of EUR 1 million for any one accident. The insurance company is Pohjola Vakuutus Oy.

According to Finnish traffic law every car must have Motor Vehicle Insurance. The Organiser will acquire the insurances for foreign racing cars. Information about the cars must be sent to the Secretary of the event latest on Monday 2nd of June.

NOTICE! This insurance does not cover driver's personal damages / bodily injuries. Please make sure that personal insurances for the drivers are adequate.

License holders of other ASN's are deemed to be insured for Personal Accidents with their own ASN.

Article 5 – Protests and Appeals

The AKK protest fee is EUR 300 paid when making the protest. The appeal fee set by the ASN is EUR 1,000.

All protests will be lodged in accordance with the FIA International Sporting Code and the 2025 AKK Regulations book. All protests must be made in writing and handed to the Chairman of the Stewards, or in his absence one of the other Stewards of the Competition, or in their absence to the Race Director or Clerk of the Course (or their assistant) together with the required protest fee.
