Rally car needs to be equipped with normal winter tyres (rally tyres not allowed)

# Reservation to Safety Inspection on Slot reservation system. (Not valid / required for classes 18-26)

The competitor must go to website <a href="www.rallism.fi">www.rallism.fi</a>, (link can be found below the main picture SCRUTINEERING TIMES (<a href="https://slotti.fi/booking/rallism/">https://slotti.fi/booking/rallism/</a>),

slots reservation system, where competitor need reserve free time which he thinks to best suit himself. Reservation must be done either for a basic scrutineering or turbo Scrutineering.

Also fill the information documents requested on the online form.

Choose basic checking for cars without Turbo/ compressor

Reservation for Safety Inspection opens in internet, "Slott" – system and needs to be done between 22.02 – 27.02 (10:00 PM) valid only for classes 1-17.

If reservation is not done, penalty fee will be 50€, and it needs to be paid latest 1,5h before competitors start time.

Competitor needs to check-in to Safety Inspection Office latest 10 minutes before own reserved time, when his presence will be recorded and all documentation will be checked as per regulations

Late in check in will cause 50€ penalty, and it needs to be paid latest 1,5h before competitors start time.

Negligence to pay this fee will result in refusal to start with Clerk of the Course's decision. After approved document check, competitor can move forward to scrutineering

In Safety Inspection all turbos and pop-off valves, used in competition, will be checked. If the competitor has not reserved any scrutineering time, the organiser reserves the right to place them in the scrutineering timetable at a slot considered suitable and to collect a fee of 50€ for this.

The same fee applies if the competitor is late from the time reserved and a new time is given. Should the competitor further be late from this new time, the Clerk of the Course may refuse them to start.

Should the competitor wish to change his Safety Inspection time after closing of the reservation system, the organiser will collect of fee of 50€ for this. The organiser cannot guarantee the possibility to change the reservation.

If Competitor needs to change pre- reserved Safety Inspection time, organizer will charge a fee of 50€. Possibility for new time cannot be guaranteed.
