REGULATIONS

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

RALLY NORDIC

According to Finnish traffic law every car must have traffic insurance. AKK Motorsport will acquire the insurances for foreign racing cars. Information about the cars must be sent to the secretary of the event latest 10 days before the event. Needed information: Competition class, car manufacturer, car model and chassis number. Price for the insurance is EUR 30 / car. Competitors must pay the traffic insurance in administrative checking on Saturday 24.8.2019.

Article 5 – Protests and Appeals

The appeal fee set by the ASN is EUR 1000.

All protests will be lodged in accordance with the Sporting code. All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the Competition, together with the required protest fee.
